

Terms and Conditions

Unless varied by written endorsement goods are sold upon the following conditions which shall supersede any conflicting terms in your order.

PRICES are quoted in British Pounds and are subject to a revision at any time after the date of any quotation due to any change in the costs incurred by ourselves. The price of the Goods shall be the Sellers quoted price and the Seller reserves the right by giving notice to the Buyer at any time before delivery to increase the price of the Goods to reflect any increase in the cost to the Seller. The price is exclusive of any applicable value added tax. The Buyer shall not be entitled to make any deduction from the price of the goods for any set off or counterclaim unless both the validity and the amount thereof have been admitted by the Seller in writing.

PAYMENT Unless otherwise agreed the price for the goods shall be paid to the Seller within thirty days of the date of the Seller's invoice notwithstanding that delivery may not have taken place and the property in the Goods has not passed to the Buyer. The time of payment of the price shall be of the essence of the Contract. Otherwise payment will be as stated on the quotation given. Default of payment shall entitle us to treat any outstanding orders as cancelled.

DELIVERY shall be when the goods are acceptable by a representative of your company, whether delivered or collected. Delivery dates are given in good faith and we shall do our best to comply, but we accept no liability for deviation from these dates due to reasons beyond our control i.e. strikes, act of God, material shortages etc. We reserve the right to deliver in instalments.

OWNERSHIP shall pass upon payment in full for all goods and packaging supplied. You are liable for any damage, loss or claim howsoever caused during the period from receipt to payment.

VARIATION Great care is taken in the manufacture of our inks. However, variation can occur during printing and with substrate materials, accordingly no guarantees can be given on colour or other properties. Our customers are strongly recommended to check inks for adhesion, colour accuracy and suitability for use prior to commencing production.

VARIATION OF QUANTITY is permissible up to 10% above or below that ordered. Actual quantities delivered will be charged.

CLAIMS for damage, partial loss or any other reason is to me made within 3 DAYS from receipt in writing.
